## FACILITIES AND STAFF

Jamestown 4-H Center is located near Jamestown on the beautiful James River. Campers will be housed in air-conditioned cabins with bunk beds and modern bathroom facilities. Meals will be provided by our food service professionals and served Family Style. Cabins and activities will be chaperoned by both teen and adult counselors with a ratio of one counselor to five campers.

## REGISTRATION INFO

### How old is my camper?

Youth 5-8 years of age may attend. Youth must reach their fifth birthday by September 30, 2012 and must not have reached their ninth birthday before the first day of the camp.

### What about volunteering?

Counselor and leadership opportunities are available for Teen and Adult volunteers. Cost for Teens is \$15. Adults are free.

### Can we get a ride?

Although we do encourage carpooling, transportation is not provided by the Jamestown 4-H Center.

### Where is the camp?

Jamestown 4-H Center is located on the beautiful James River, just one mile from Jamestown Island and the Colonial Parkway, and five miles from Colonial Williamsburg. It is an easy drive from anywhere in Hampton Roads or Richmond.

## CAMP FEE

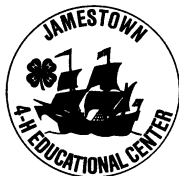
